Deep-penetrating primer concentrate for preparing mineral surfaces prior to finishing works. Diluted with water before use. For interior and exterior use.

2. Hazards identification

2.1 Classification of the substance or mixture

Regulation (EC) No 1272/2008 (GHS): Skin Sens. — skin irritation (possible).

2.2 Label elements

EUH208 — Contains 1,2-benzisothiazol-3(2H)-one. May cause an allergic reaction.

3. Composition/information on ingredients

Composition: Water, aqueous acrylic copolymer. Contains 1,2-benzisothiazol-3(2H)-one (CAS 2634-33-5) — may cause an allergic skin reaction (EUH208).

Hazardous components: 1,2-benzisothiazol-3(2H)-one (CAS 2634-33-5).

4. First aid measures

General measures: In case of allergy symptoms, especially in the respiratory tract, seek medical attention immediately.

After inhalation: Move the person to fresh air.

After skin contact: Wash with soap and water, rinse.

After eye contact: Rinse immediately with plenty of water for 10-15 minutes. See a doctor if irritation persists.

After ingestion: Rinse mouth. Do NOT induce vomiting. Seek medical attention.

5. Firefighting measures

Extinguishing media: Not flammable under normal conditions.

Fire hazard: Non-flammable. **Explosion hazard:** The product is not explosive.

6. Accidental release measures

Avoid splashing and allowing the product into drains. Contain spillage with a suitable absorbent, dispose of in accordance with waste legislation.

7. Handling and storage

Store in the manufacturer's tightly closed original container. 24 months in sealed original packaging, at a temperature of +5 to +35°C.

8. Exposure controls/personal protection

Observe general hygiene measures when handling chemicals. Avoid inhaling vapours. Use protective gloves and eye protection for prolonged contact.

9. Physical and chemical properties

Form: Liquid (concentrate, before dilution with water).
VOC content: max. 8 g/l

10. Stability and reactivity

No hazardous reactions are known under normal conditions of use. Avoid direct sunlight and storage outside the permissible temperature range.

11. Toxicological information

EUH208 — Contains 1,2-benzisothiazol-3(2H)-one. May cause an allergic reaction. No other toxicological data is available.

13. Disposal considerations

Dispose of in accordance with local/national regulations. Uncleaned packaging should be disposed of in the same way as the substance itself.

14. Transport information

Not regulated for transport. The product is not classified as dangerous goods for domestic/international transport by road, sea, or air.

15. Regulatory information

Labelling in accordance with Regulation (EC) No 1272/2008 (CLP): EUH208 — Contains 1,2-benzisothiazol-3(2H)-one. May cause an allergic reaction.
